# 2) Application for the Competition, terms of participation

- a) Participation in the Competition is open only to natural persons with the capacity to act and at least 18 years of age, provided that they fully meet all the criteria set out in these Rules and none of the grounds for exclusion from the Competition apply.
- b) Further eligibility criteria for participation in the Competition are described in Section 3 of these Rules.
- c) Participation in the Competition is subject to the acceptance of these Rules and the Privacy Notice. By entering the Competition, the Applicants express their acceptance of the Rules and the Privacy Notice.
- d) Employees of the Organiser or their close relatives as per Section 8:1 (1) of Act V of 2013 on the Civil Code, including the employees of companies in partnership with the Organiser and the partners themselves, may not participate in the Competition.
- e) During the Competition at the Organiser's discretion Players may be excluded and disqualified if their conduct is not worthy of the standards of the Competition or the BioTechUSA brand. ### 3) <u>Description of the Competition</u>

# 4) **Duration of the Competition**

Any applications submitted before the start or after the end of the Competition shall be void, and will not be accepted by the Organiser.

5) <u>Prize</u>

- a) The Organiser shall draw the winners from the Players meeting the criteria of these Rules with the help of a program operating on the principle of randomness on the date of 10/10/2023.
- b) Three winners will be drawn.
- c) The draw by the Organiser is final and cannot be changed.

# 6) <u>Rules concerning the prizes</u>

- b) The Controller uses only the personal data specified in the Privacy Notice for holding the Competition. Detailed information on the processing of personal data by the Organiser is available in the Privacy Notice.
- c) During the Competition the Participants may only provide their own personal data. The Controller assumes no liability for damages arising from the processing of inaccurate, or unlawfully or incorrectly provided data.

### 8) Miscellaneous provisions

- a) Entering the Competition does not automatically entitle the Player to win a prize.
- b) By participating in the Competition, the Applicants expressly consent to the publication of their names, without any other compensation or authorisation, on any of the social media pages of the Organiser, should such Applicant win a prize.
- c) The Organiser assumes no liability for any errors or deficiencies arising during registration for the Competition, nor for any delay in delivery.
- d) All consequences arising from incorrect data provided by Players or from the failure of their e-mail account or Instagram profile to receive messages shall be borne by the Players themselves.
- e) The Organiser assumes no liability if the Competition or the website containing the Competition becomes periodically unavailable for technical reasons during the Competition.
- f) Applicants who contrary to the spirit of the Competition participate in the Competition with untrue character or untrue data, or with photos they do not own, as well as those who cheat in order to increase their chances of winning through such deceptive and unfair conduct, may be automatically excluded from the Competition.
